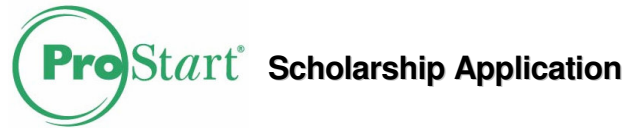

(2) \$1,000 Scholarship Awards

The **Metro Denver Hotel Association** in partnership with the **Colorado Restaurant Association Education Foundation** awards scholarships to qualified students in hotel/hospitality management programs. Applicants must have demonstrated strong interest in the lodging/hospitality industry as evidenced through documentable work experience in the industry.

Eligibility Criteria:

Note: Any applications which do not meet the following criteria or are not legible will be automatically disqualified.

- Be enrolled in the ProStart® program at your high school or in your school district
- Be accepted into an approved postsecondary program, starting Fall 2009 term
- Have a minimum **Final, Overall Grade Point Average of 2.75** on a 4.0 scale
- Have industry-related work experience of at least 250 documented hours**
- Demonstrate interest in lodging industry

Please Return:

- Your Application, typed or printed clearly, indicating "N/A" (not applicable) when appropriate
- An official high school transcript sent directly from high school to our offices
- A Resume
- Documentation of industry related work experience (**verified by copies of paycheck stubs or letter(s) from employer(s) stipulating number of hours worked)
- Two letters of recommendation. At least one letter must be from a current or previous employer. Teacher recommendations are also welcome.
- A "Letter of Intent" stating that you are enrolled/enrolling in an accredited foodservice/hospitality related program for a minimum of 9 credit hours (ie: your college "acceptance" letter)

Judges will score the following:

- Grade point average
- Industry-related work experience and/or hospitality-related course work
- Contents of the letters of recommendation
- Essay questions on application (*questions should be answered carefully and clearly in essay format*)

Incomplete applications will not be considered.

Deadline, award announcement and payment timeline:

- March 27, 2009 – application and transcripts must be postmarked. *No exceptions, please.*
- April 30, 2009 – award recipients formally announced at annual CRA Education Foundation Scholarship Awards Luncheon. Additional details will be provided at the time of award notification, but please make note of this date on your calendar.
- Funds will be disbursed in two equal payments, the first half in September 2009 and the second half in January 2010 upon verification of your continued enrollment in a qualified program.
